The students gain a verse sense of knowledge through this workshop. The programme was a profitable and enjoyable for the students.

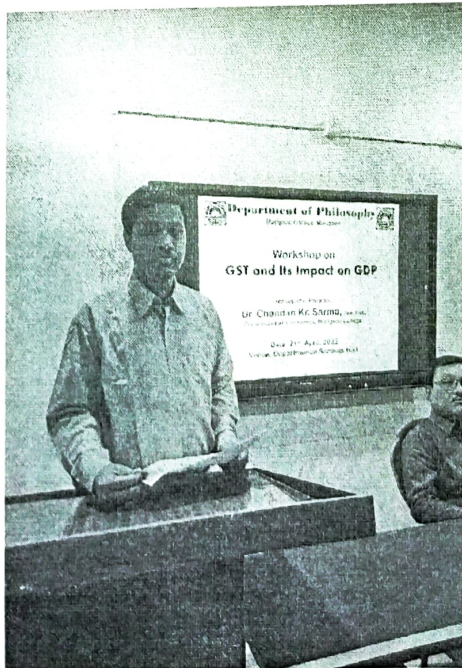
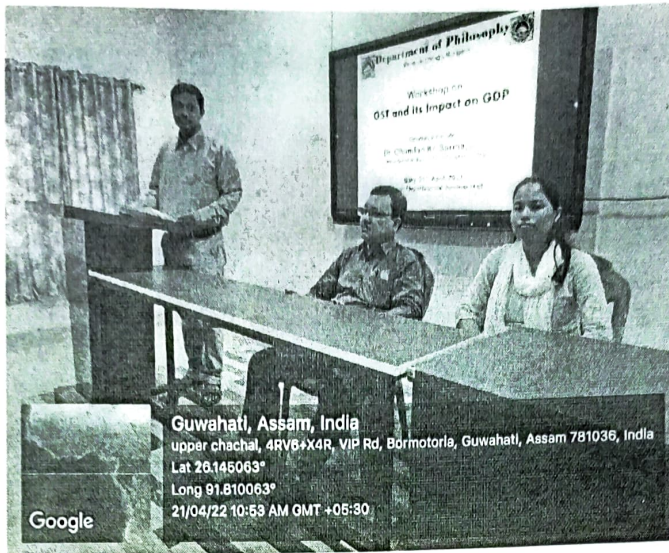
